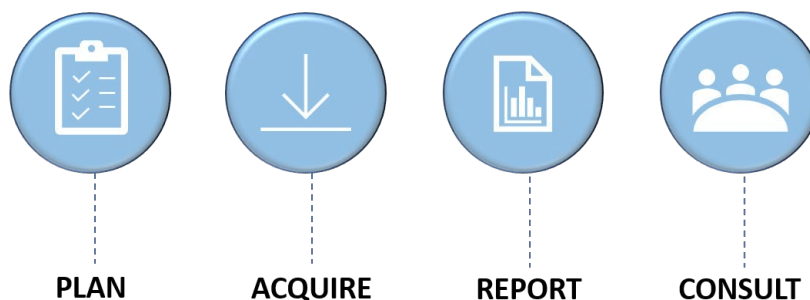

### PLAN
